

**HOW TO ENROL IN A BACHELOR DEGREE  
OR IN A SINGLE CYCLE MASTERS DEGREE PROGRAM  
ENROLLMENT PROCEDURE FOR NON EUROPEAN UNION STUDENTS**

You belong to this category if you are a non-EU citizen and are resident outside Italy when you submit your application for pre-enrolment to the university. The number of places available to these students is restricted and the quota for each course is fixed annually.

The application process is as follows:

- If you want you can have a preliminary assessment of your educational background in order to obtain an eligibility letter for enrolment.
- pre-enrolment on your chosen university course: the pre-enrolment application form for your chosen program must be submitted to the [Italian diplomatic representative](#) in the country where the qualification was awarded through the online system you can find on [www.universitaly.it](http://www.universitaly.it) ;

These are the step to follow if you want to enrol at the University of Catania:

1. **Check** the list of available seats to see whether there are available places in the course you are interested in. The pre-enrolment can be carried out for **one course only** among those indicated. The list is usually available from March at the embassies and consulates and can be found also at this web address: <https://www.studiare-in-italia.it/studentistranieri/> ;
2. Contact an ENIC/NARIC evaluation center in order to obtain a “**Statement of comparability**” of your Secondary School leaving qualification. The procedure is online, you can do it through Cimea web site: <http://www.cimea.it/en/index.aspx> .  
If you prefer you can eventually contact the Italian Embassy in the country where the qualification was awarded in order to obtain the “**Dichiarazione di valore in loco**” **DOV** (for the high school diploma).
3. If you need a pre admission letter for the Italian Embassy **fill in** our online [form](#) (from March till 30<sup>th</sup> June) for the evaluation of application by entering your personal and academic data and upload the required documentation (Copy of the passport, Statement of comparability or DOV and language Certificates are compulsory).
4. Once you have entered your data and uploaded the documents submit the online application form for administrative review. You will receive an e-mail (normally within 30 days and not later than 2 months) informing you of whether or not you can proceed

to pre-enrolment through the pre enrolment system. **The request of the eligibility letter it is not compulsory to enter a Bachelor degree!**

5. **Apply** for pre-enrolment through the [www.universitaly.it](http://www.universitaly.it) website once received the approval form the University ask to the embassy a visa type D "Application to Italian Universities".
6. **Contact the Foreign Students Office** [sestat@unict.it](mailto:sestat@unict.it) to check the procedure to register for entry test and if you have to take Italian language test.

**Remember that all the Bachelor courses are in Italian and a B2 knowledge of the language is required, if you don't a certificate stating your level of knowledge of the language you'll be required to pass a test.**

**Remember:**

The University does not offer [housing service](#), so please find a place where to sleep before you arrive in Catania.

ERSU gives the possibility to stay for a short period (max 90 days) in their guesthouses
