**ADDENDUM TO THE CALL FOR APPLICATIONS - PH.D. COURSES - XXXV CYCLE -
UNIVERSITY OF CATANIA, ISSUED BY DOYEN'S DECREE N. 2123 OF JULY 5 2019**

THE DOYEN

Having regard to the following:

- Ministerial Decree n. 45, 08/02/2013, "*Regolamento recante modalità di accreditamento delle sedi e dei corsi di dottorato e criteri per la istituzione dei corsi di dottorato da parte degli enti accreditati*";
- The Regulation on Ph.D. courses currently in force the University of Catania;
- The Call for applications-Ph.D. Courses XXXV cycle, issued by Doyen's Decree n. 2123 of July 5 2019;
- Annex 13 of the aforementioned call concerning the Ph.D. course in "Science of Interpretation";
- Article 14, pt. 1, of the aforementioned call, which stipulates that the administration considers the possibility of modifications, updates or integrations - to be exclusively advertised through www.unict.it (section "*Bandi, gare e concorsi*" > "*Studenti e Post laurea*" > "*Dottorati di ricerca*") - in case the number of places with scholarships, and consequently the number of places without scholarships, increases due to further funds made available after the issuing of this call, provided the respect of the terms of assignation of places to candidates on the pass list;
- The agreement signed by the legal representative of *Fondazione "Cesare e Doris Zipelli - Banca Agricola Popolare di Ragusa* and received on July 8 2019, concerning the funding of an additional scholarship for the Ph.D. course in "Science of Interpretation"- XXXV cycle related to a research theme in the field of linguistic mediation and to be considered reserved to holders of *laurea magistrale* obtained from the Didactic Unit - Foreign Languages and Literatures of Ragusa;
- The necessity of redefining the number of places related to the Ph.D. courses in "Science of Interpretation", in consideration of the agreement signed by the legal representative of the aforementioned body was received after the date of publication of the aforementioned Call;

DECREES

The call for applications - Ph.D courses, XXXV cycles of the University of Catania, issued by Doyen's Decree n. 2123 of July 5 2019, is integrated as follows:

Art.1 The number of places with scholarships concerning the Ph.D. course in "Science of Interpretation" is redefined as indicated in Annex 13, with the number of available places being increased by one (1) according to what stated in the premises.
