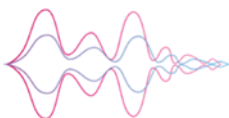
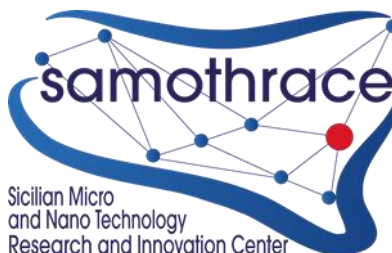

- Article 14, paragraph 1, of the abovementioned call “This call can be integrated in case the number of places with scholarships increases due to further funds made available by no later than July 15th 2023.”;
